# Disaster Recovery Funds to Be Spent in Linn and Benton Counties



The State of Iowa was awarded \$57.5 million in Federal Disaster Recovery Funds as a result of the August 10, 2020 derecho storm. The Iowa Economic Development Authority (IEDA) is currently taking public comment on a draft plan for these funds. The State intends to use 80 percent of the funds (over \$47 million) in Linn County and 20

percent (over \$16 million) in Benton, Marshall, and Tama Counties. The draft plan proposes a majority of these funds be used to create or rehabilitate housing, with additional portions going toward tree replacement and generator purchases for critical facilities.

A virtual public hearing will be held on Thursday, May 26 at 6:00 p.m. The Draft Action Plan, information about the hearing, and opportunity to provide comments are all available on the IEDA <a href="website">website</a>. The IWA was funded by the Department of Housing and Urban Development (HUD) in 2016 to reduce flooding and improve water quality throughout the state. ### **Johnson County Purchasing Flood-Prone Properties**



Johnson County was awarded grant funding to purchase three repetitive loss properties in partnership with lowa Homeland Security and Emergency Management and FEMA through the Hazard Mitigation Assistance Program. These properties repeatedly suffer from flooding due to their location in the lowa

River floodway. ECICOG wrote the County's application and is administering the grant. From appraisal to removal, ECICOG is working with homeowners while managing services, contracts, proposals, and grant timelines. Purchase offers are currently being written, thanks in part to additional funding to assist with a fair purchase price in the current housing market.

To qualify for Hazard Mitigation Assistance funding, a county, city, or school district must have a project included in a FEMA-approved hazard mitigation plan. # Calling All Commuters and Employers: CorridorRides Can Save You Money!

Gas prices, maintenance costs, insurance premiums – commuters are seeing the cost of their drive increasing across the board. ECICOG has two ways to help relieve

commuting costs: the 380 Express and the VanPool program. The 380 Express bus runs Monday through Friday, with six stops in Cedar Rapids, Coralville, and Iowa City to provide an alternative for I-380 commuters. Learn more here.

The CorridorRides Vanpool program is another option – a simple, sustainable and cost-effective method of commuting to work. Vehicles are provided for groups of 7-15 commuters to ride together at a reduced rate. These vehicles come with maintenance packages, paid insurance costs, and



roadside assistance. In March, ECICOG announced that new VanPool groups formed by September 2022 will receive two months free! Two companies are in the process of forming CorridorRides VanPools, making nearly a dozen commuters' lives easier.

### City of Coggon Adds Urban Agricultural District



ECICOG recently partnered with the City of Coggon to amend their zoning ordinance. The City is adding an urban agricultural district, an appropriate use of land not yet incorporated into urban uses (housing and commercial buildings). The district's requirements are more conducive to farming operations while maintaining compatibility with neighboring urban development – e.g. allowing larger

accessory buildings but restricting livestock. This is consistent with Iowa Smart Planning Principles, which call for the protection, preservation, and restoration of agricultural land. The City of Coggon also added an updated zoning map which is easier to read and includes the urban agricultural district.

#### **Destination Iowa**

Applications accepted until funds expended lowa saw record use of outdoor amenities such as state and county parks over the last two years, but a decrease in visitor spending and hospitality employment. The lowa Economic Development Authority (IEDA)'s program Destination lowa is a \$100 million investment in attracting

visitors and new residents to the state. Intended to bolster quality of life in Iowa's communities, the new effort will provide grants for shovel-ready attraction projects. Cities, counties, nonprofits, and other organizations can apply, and applications will be accepted through the calendar year or until the funds are expended. #### Meet In Iowa

Applications reviewed upon receipt

Receive a one-time reimbursement of eligible hard costs for your organization's 2022 meeting, conference, festival, sporting, or other event through the Meet In Iowa program from the IEDA and Iowa Tourism Office. The goal of the program is to attract, retain, and expand in-person overnight



events. Event organizers can receive up to \$25,000 in reimbursement for costs associated with meetings between May 1 and December 31, 2022. Learn more about eligible costs at the Meet In lowa website.



#### **National Trust Preservation Funds**

Due June 1

Grants from National Trust Preservation Funds (NTPF) are intended to encourage preservation at the local level by providing seed money for preservation

projects. These grants help stimulate public discussion, enable local groups to gain required technical expertise, introduce the public to preservation concepts and techniques, and encourage financial participation by the private sector. ### **Enhance Iowa Sports Tourism**

Due June 1

The new Enhance Iowa Sports Tourism program provides financial assistance for projects that market or promote sporting events in Iowa. The sporting events can be at professional, collegiate, and amateur levels, and the promotional or marketing activities can



occur for up to two years. Cities, counties, economic development organizations, and other not-for-profit organizations can apply. The program will cover up to 50% of eligible promotion costs, including advertising, payment to vendors, equipment rentals, and more. ### **Iowa Living Roadway Trust Fund**

Due June 1

Working through many partners in Iowa, the Living Roadway Trust Fund supports integrated roadside vegetation management and educates the public on the benefits, use, and care of roadside vegetation, including native plants. Counties and cities are eligible.

### State Workforce Housing Tax Credit Program

Due July 1



This program provides tax benefits to developers to provide housing in Iowa communities, focusing especially on those projects using abandoned, empty, or dilapidated properties. There is a total of \$25 million available, with \$15 million set aside for small communities in Benton, Iowa, Jones, and Washington Counties. There is an additional developer tax initiative up to \$150,000 in value. Visit <a href="the IEDA website">the IEDA website</a> for eligible project types and program requirements.

#### **CDBG - Water & Sewer**

Due July 1

The program is funded through the federal Community Development Block Grant (CDBG) with the goal of providing economic opportunities for people, especially those of low- and moderate income. Funds awarded through this annual competitive program assist cities and counties with projects such as sanitary sewer system improvements, water system improvements, water and wastewater treatment facility projects, storm sewer projects related to sanitary sewer system improvements and rural water connections. The Iowa Department of Natural Resources (DNR) works to reduce the amount of waste landfilled in Iowa through the Solid Waste Alternative Program (SWAP). SWAP provides financial assistance toward source reduction, recycling, and education projects such as installing waste reduction equipment, developing educational materials, or purchasing

### **State Recreational Trails Program**

Due July 1

The state recreational trails program (SRT) provides funds to establish recreational trails throughout Iowa for the use and enjoyment of the public. Federal, state, or local agencies can apply to fund the acquisition, construction, or improvement of public trails. ### Iowa's Living Roadways Community Visioning

Opens July 1, Due September 15

The Community Visioning Program assists Iowa

communities of 10,000 or fewer with surface transportation improvements such as providing pedestrian or bicycle facilities, beautifying routes, preserving historic sites, or converting unused rail corridors to trails. The program takes communities from identifying their surface transportation needs and developing a community vision to initiating project development. Communities that lack planning resources within the city government are prioritized. Learn more at the Community Visioning website.

### Theisen's More for You Community Grants

Opens July 15, Due August 31

The Theisen's More For You grant program is intended to directly serve the basic needs of families and children. Programs that assist basic health needs, children's needs, educational



programming, food security, or youth services will be prioritized. To date, Theisen's has awarded over \$3 million to their communities. Any community within 60 miles of a Theisen's store is eligible to apply. Click here to find applications and more details about the program.



### **Traffic Safety Improvement Program**

Due August 15

The Iowa Department of Transportation (DOT)'s Traffic Safety Improvement Program (TSIP) provides funds for roadway safety improvements, traffic control devices, research, studies, or public information initiatives. Cities and counties can submit

### **REAP City Parks and Open Spaces**

Due August 15

This program's intent is to protect open spaces, in turn enhancing lowa residents' quality of life, supporting

economic development efforts, and taking precautions to care for the environment. The Resource Enhancement and Protection (REAP) City Parks and Open Spaces funds are typically used for parkland expansion and multi-purpose recreation developments. Because these grants do not require a local match, the program is competitive. ### **Hazard Mitigation Grant Program**

Due December 23

As part of the Presidential disaster declaration from December 2021's severe storms, the State of Iowa will receive FEMA disaster funding under the Hazard

Mitigation Grant Program (HMGP). The State is accepting Notice of Interests (NOIs) for projects that will reduce or eliminate losses from future natural disasters. These include but are not limited to:

- Property acquisition/elevation, electric utility hardening, detention basins, warning sirens
- Elevate/protect wastewater lift stations, backup generators
- Tornado safe rooms, small flood barriers

Projects must be included in a FEMA-approved hazard mitigation plan. Full grant applications are due by December 23, 2022. Contact Alicia Presto at <a href="mailto:alicia.presto@ecicog.org">alicia.presto@ecicog.org</a> for information about the NOI process.
