## .1 Election of Officers

#### .2 IIJA Update

Rump provided an update on the process to determine how statewide STBG and TAP formula funds will be distributed to MPOs and RPAs. A small stakeholder group has been meeting. Their final meeting is planned for April 19. After that meeting, their recommendation will be forwarded to stakeholders statewide for comment. Iowa DOT has indicated that although IIJA included an increase in STBG funding, much of that will result in an increase in TAP. Once significant issue to resolve is the continuation of the SWAP process. It can't continue in its current form since there aren't sufficient state funds to swap for the federal funds.

## 3.3 Review STBG Applications and Priorities

Five new applications were submitted. The counties have recommended funding all of them at the level of funding requested, except for the North English application. Iowa County borrowed forward last year and in accordance with the regional policy, the negative balance must be zeroed out before funding additional applications. Since negative balance still exists, no new application can be funded from within Iowa County. Rump also noted that the application from Washington County exceeds their targeted funds, so they will be borrowing ahead. There are sufficient regional funds to allow for this.

M/S/C (N. Amelon, Burke) to recommend funding the applications received and the funding amount requested, except for the North English application which will not receive funding. All ayes.

#### 3.4 Long Range Transportation Plan Update

Rump mentioned that some draft chapters of the long range plan have been prepared based on input provided through the Envision East Central Iowa Process. A survey will go out on April 1 to seek input about transportation needs and priorities. The survey and draft chapters will be available on ECICOG's Talk to ECICOG site. Additional information will be emailed to committee members on April 1.
