### **ECICOG Awarded \$4.675 Million for Revolving Loan Program**




ECICOG was awarded \$4.675 for the revolving business loan fund as part of the Economic Development Administration's (EDA) CARES Act Recovery Assistance. This award will effectively double the size of the revolving loan program and allow

### **Watershed Planning Work Expands**

ECICOG is a leader in the state of Iowa when it comes to watershed planning and securing grant funding for watershed improvement projects. This summer our work is expanding to the Lower Cedar River watershed, which includes the counties of Linn, Jones, Johnson, Cedar, Muscatine, Scott and Louisa. ECICOG is partnering with FYRA Engineering to



complete the Lower Cedar Watershed Management Plan. Once the plan is completed, the Lower Cedar Watershed Management Authority will be eligible for state and federal grants to improve water quality and mitigate flood risk. ### **Transportation Funding Impacted by COVID-19**



In mid-June, cities and counties received their monthly allocation of Road Use Tax Funds (RUTF). These allocations were smaller than those received in previous months. Although a portion of the variation

in allocations was not related to COVID-19, Iowa Department of Transportation has estimated that approximately 20 percent of the decrease is COVID-19 related. RUFT revenues are derived from state fuel tax receipts, vehicles registration renewals, and new car registrations. Iowa DOT has projected that between June-October, allocations will continue to be about 20 percent lower than normal. They are estimating about a 10 percent reduction between November 2020 and June 2021.

There continues to be a lot of discussion in Washington, D.C. of federal backfill for lost state transportation revenues; however, it does not appear to be a priority for immediate action. There is also discussion about significantly increasing highway funding through the federal surface transportation program. If enacted, the additional funds might help to offset reductions in state revenues. Federal stimulus funding, if approved, could also provide additional funding for transportation projects.

## **REAP - City Parks & Open Spaces**

Due: August 15

These grants are 100%, so local matching funds are not required. This grant program is very

competitive. Funds are not available for single or multipurpose athletic fields, baseball or softball diamonds, tennis courts, golf courses, and other organized sport facilities. Swimming pools and playground equipment are also ineligible. Parkland expansion and multi-purpose recreation



developments are typical projects funded under this REAP program. The DNR administers the city grant program. **Click here for more information.** 

### **REAP - Conservation Education Program**

Due: August 20



The conservation education program shall serve lowa citizens by providing effective curricula, program materials and educator stipends to increase environmental awareness and understanding of stewardship, and enhance natural resources. Applications

may be submitted by institutions of higher learning, government agencies, including local school districts, nonpublic schools, area education agencies, organizations, and individuals with an lowa residence. Click here for more information.

### **Traffic Safety Improvement Program**

Due: August 15

This program is to distribute funds for roadway safety improvements, traffic control devices, research, studies or public information initiatives.

Applications are reviewed by an internal/external committee of representatives from cities, counties and



the Iowa DOT. Recommendations are then made to the Iowa Transportation Commission, which then approves funding of specific projects. Click here for more information.
