The agenda for the May 18<sup>th</sup> Policy Committee meeting is attached. Some agenda items have been highlighted below. I might also remind you that we will be meeting via Zoom. A Zoom invitation should have been sent to you separately.

**Item 3.1 Election of Officers:** The current officers include Jon Zirkelbach - Chairperson, Rod Sullivan – Vice Chairperson and Bob Yoder – Secretary. The bylaws allow each officer to serve two consecutive terms. Zirkelbach has served two terms as Chair and is not eligible to serve another. Sullivan and Yoder have each served one term in the respective office and are eligible for re-election.

Item 3.2 Consider Transportation Alternative Program (TAP) Funding Recommendation: The region received two applications for TAP funds during the most recent application cycle. The Regional Trails Advisory Committee (RTAC) has reviewed the applications and recommended funding (\$125,000) for continued funding for the Johnson County Clear Creek Trail project and partial funding (\$81,000) Linn County Grant Wood Trail project. Copies of the applications are provided.

Item 3.3 Consider Surface Transportation Block Grant (STBG) Funding Recommendation: The region received five applications for STBG funding. Following a review of the applications by respective county boards of supervisors and the Transportation Technical Advisory Committee (TTAC), four of the applications are recommended for funding. Copies of the applications and a summary of the recommendation are provided.

Item 3.4 Consider Approval of the FY 2023 Transportation Planning Work Program (TPWP): Each year, the region submits the TPWP to document how federal funds will be used for transportation planning purposes. The committee will be asked to consider approval of the adopting resolution

#### Item 3.6 Consider Amendments to FY 2022-2025 TIP

The RPA previously received two requests for TIP amendments. Funding for these requests didn't affect any prior regional programming or other local projects. Accordingly, the necessary changes were made in TPMS and the committee is now being asked to formally approve them

- Johnson County Conservation was awarded \$388,000 in Federal Rec Trail funds from lowa DOT for the Clear Creek Trail, from Half Moon Avenue to F.W. Kent Park. This project will appear in the FY 2023 program.
- 2. City of Wellman was awarded \$1,000,000 in City Bridge funds for FY 2022 from Iowa DOT form the 9<sup>th</sup> Avenue bridge over Smith Creek. To be eligible to receive the funds, the project must be amended into the Transportation Improvement Program.
