Re: Next Policy Committee Meeting – April 29, 2021 @ 1:00 pm

The agenda for the April 29th Policy Committee meeting is attached. Some agenda items have been highlighted below. I might also remind you that we will be meeting via Zoom. A Zoom invitation should have been sent to you separately.

Item 3.1 Election of Officers: The current officers include Jon Zirkelbach - Chairperson, Les Beck – Vice Chairperson and Vicki Pope – Secretary. The bylaws allow each officer to serve two consecutive terms. Zirkelbach has served one term as Chair and is eligible to serve another. Beck has retired from the committee and Pope has served two terms as secretary, so new officers are required for these positions.

Item 3.2 Public Hearing for the Passenger Transportation Plan (PTP) 2021-2026: Every five years, the region is required to update the Passenger Transportation plan to coordinate passenger transportation services and to ensure that citizens have access to passenger transportation options. The public hearing is required prior to approval of the PTP.

Item 3.3 Consider Approval of PTP 2021-2026: In addition to the public review, the draft PTP was also made available to lowa DOT for review and comment. Iowa DOT comments have been incorporated into the final draft. The committee will be asked to consider approval of the adopting resolution.

Item 3.4 Consider Transportation Alternative Program (TAP) Funding Recommendation: The region received five applications for TAP funds during the most recent application cycle. The Regional Trails Advisory Committee (RTAC) has reviewed the applications and recommended funding (\$250,000) for the Johnson County project and partial funding (\$137,000) Linn County Grant Wood Trail project. Copies of the applications and a summary of the recommendation are provided.

Item 3.5 Consider Surface Transportation Block Grant (STBG) Funding Recommendation: The region received nine applications for STBG funding. Following a review of the applications by respective county boards of supervisors and the Transportation Technical Advisory Committee (TTAC), eight of the applications are recommended for funding. Copies of the applications and a summary of the recommendation are provided.

Item 3.6 Consider Approval of the FY 2021 Transportation Planning Work Program (TPWP): Each year, the region submits the TPWP to document how federal funds will be used for transportation planning purposes. The committee will be asked to consider approval of the adopting resolution
